

June 17, 2022

By motion of the Church Council, there will be a Special Congregational Meeting of the Red Lodge Community Church at 11:00 am (following worship) on Sunday July 3. This meeting is being called to consider and move to open the Bob Moran Endowment to fund the restoration of our church's Fellowship Hall, Elevator, Air Conditioner, Playground, and any other facilities repair or restoration as the result of the June 12 Flood.

Like most businesses in Carbon County, we do not have flood insurance coverage. The Facilities Committee is in the process of evaluating the damage and the Church Council is investigating all possible avenues of financial assistance for the projects that will need to be done. The current damages seem to be: Elevator Electronics System, Fellowship Hall floor and walls, Playground Base and possibly equipment replacement, HVAC unit. We are in contact with all of the necessary companies to give us bids and estimates. We will need access to the endowment funding to pay for these repairs as we go, which need to be done as immediately as possible where we cannot cover the recovery expenses through other means. Thank you for your patience as we move into these unprecedented times.

Management Policy for the Moran Endowment

The purpose of this document is to guide the management of the Moran endowment.

On 4 29 19 the Congregation voted that the entire Moran funds should be invested in the UCC Church's Balanced Fund Account (SR) as an account separate from the Chamberlain Endowment. Income from the Moran fund may be used to supplement the general budget as needed.

The Moran investment will be managed by the Finance Ministry

Additional gifts may be added to this account. Gifts may be bequests, memorials or direct gifts.

Funds available from the Moran endowment will be calculated as of June 30 each year. The funds will be available for disbursement as of January 1 of the year following the June 30 measurement.

A spending formula governs the portion of total return available each year for use by the general budget with the objective of maintaining purchasing power of the fund relative to inflation. Under current policy, 4% of the 5- year average market value of the principal is calculated and transferred to the spending account. Market value of the endowment account is equal to the endowment account's opening balance, increased or decreased by the annual portfolio appreciation or depreciation, less the spending account transfer as measured on June 30 of each year.

The account will experience a "ramp-up" period until it has been fully funded and in existence for a full five-year period. During the "ramp-up" period market value will be utilized as follows, increasing to a four-year market value in year four, then maturing with the full five-year period being available:

Year 1: 3% of market value as of June 30, 2019

Year 2: 3% of average of year 1 market value after spending plus 2nd year market value

Year 3: 3% of average of year 1 market value after spending plus 2nd and 3rd year market value

Year 4: 3% of average of year 1 market value after spending plus 2nd, 3rd and 4th year market value

Year 5: 4% of the average market value of the last 5 years

Year 6 and after: 4% of the previous 5 year's market value

If the endowment is below its original value plus inflation, "underwater spending" will be determined by the Finance Ministry and approved by Council.

On occasion the Church may need to access funds from the endowment to meet urgent financial need or to finance projects for which there are supporting pledges. Upon approval by the Council and Congregation funds may be borrowed from the endowment for direct expenditure or to be used as collateral for favorable borrowing. Funds will be repaid with interest as quickly as possible, paying the IRS minimum rate at the time of borrowing. This policy recognizes that the annual distribution will temporarily fall, thereby limiting the funds available to support the annual budget.

Notes from Facilities Management: June 2022.

This month's column reports of the historic flooding in town on June 12-13. Our building had some water damage on the lower level but nothing like what happened to our neighbors across the alley. Turns out that our Church site sits on a bit of hill. Well,

actually, it is just a slight rise from 15th street, just enough of a rise to cause turn the floodwaters back towards Rock Creek at the corner 15th and Broadway. Some of that river roared down the alley in back of the Church, as seen in the photo from out the window of the back door.

The flooding had started on Sunday night and six people were staying in the Church for shelter. They were Pastor Pam and her neighbor as well as Ed and Lucy Nilsson and a couple from Illinois, Mark and Bonnie Kuller. Remember the the Quilting Group's quilts that were stored in the closet in the Fellowship Hall? (The ones that the hospitals could not take because of the Covid pandemic). The Kullers suggested putting quilts on the doorways, closing the doors over them and then rolling the quilts up against the doors and frames. That quick thinking kept much of flood-water out of the building. We wound up with about an inch of water in the hallways, kitchen, restrooms and Fellowship Hall as you can see below.









Like many of our neighbors, the Church is contracting with Alpha Omega Disaster Recovery Services. Alpha Omega has pumped out the service pit for our elevator and lent us a high CFM ducted fan to help dry out the basement. Members of the Congregation have lent seven other fans and volunteers have been helping with cleanup. Doing as much as we can with volunteers saves us on the costs of Alpha Omega's work and makes it easier for them to get done here and move on to helping others. Work done this weekend through



today (June 22) included a workday on Saturday, June 18, with seven of our congregation and about 15 people from Vineyard Church in Billings, Here's what the Fellowship hall looks like after we removed the carpeting, the cabinets and the lower 24" of drywall from the walls. (Compare that with the left hand photo above.) The refuse was hauled to the dump station next to the recycling center. (Two trips in Skip and Deb Bratton's flatbed trailer.) We expect Alpha Omega to begin work after June 27.

Other downstairs drywall – mainly that along the outside walls in the classrooms and north hallway — is marked for removal by a volunteer work party on Thursday, Jun 23. The lower 24° of drywall and insulation will be removed to enable us to dry the outside walls and framing. (The classroom carpeting was minimally scaked and can be

cleaned). Also, the water in the Fellowship Hall did not reach the furnace room so the HVAC equipment was not affected. Kyle from A&S Heating & Cooling has inspected the system components and we are able to run them. The playground and rear parking area were covered with sand and mud. The parking slab has been mostly cleared and the preschool's parents group has brought in equipment to remove the mud from the playground, a job that likely will be finished shortly. All playground equipment has been inspected and found safe. The parents' groups have a Go-Fund-Me page to contribute to buying new playground cover/chips.

Like most of Red Lodge, the Church did not have flood insurance. We will have to pay for the recovery out of the Church reserves and funds. A special congregational meeting will be held after services on July 3 to vote on whether to use some of the Bob Moran Endowment funds for cover the expenses for clean-up and restoration work, so please attend that meeting.













Volunteer Lawn Care
