Libby Gardner, moderator, commented on the phishing problem affecting our congregation. Steps have been taken to make the directory more secure. Also, the church office will be closed Monday and Tuesday, August 14 and 15. She informed us of the vandalism at a church in Miles City.

Motion to Approve the Agenda was made by Jay West and seconded by Mark Sechler. Motion passed unanimously.

Motion for the Approval of the Consent Agenda was made by Russ Lord and seconded by Steve Hanson. Motion passed unanimously.

Mark Sechler, head deacon reported that Deb Awes has resigned from the diaconate. Pulpit supply is scheduled through October.

Stewardship and Outreach is continuing work on the pledge drive for 2024. The work that was being done on the reservation is on hold.

Jay West from the Facilities Committee reported that the sanctuary air conditioner has refrigerant leaks and needs to be replaced. The Building Use Policy is still being worked on.






# **Facilities Committee**

#### FOR THE OCTOBER 2023 SHALOM Notes on our Church Building's History.

This 1941 map to the shows how our original church building and property was crowded up against houses on the north and south. Where today we have our entry ramp and the southeast end of the office and classroom wing --- that used to be a separate property. It was still vacant when our Methodist ancestors moved here in 1923. John Koski bought the lot three years later, in 1926, and built the small house and auto-repair garage that you see on the alley side in the map. The photo below is from the late 1940s shortly after James Henderson bought the next door lot from Mr. Koski's probate estate. The house is just to the right of and behind the Church, shadowed by Grazia's house (part of which is seen along the right



edge of the photo). On the other (north) side of the Church, behind the picket fence, you can glimpse the front unit of the two rental houses that were on that adjoining lot. (That lot is where we built our north addition in 2005.)



The houses were still there on both sides in 1964 when the Community Church was formed here. One of the very first things the newly merged congregation did was buy the property on the south from Mr. Henderson's probate estate. The decision to buy was made at the very first meeting of the new congregation's Board of Trustees. The property was cheap because Red Lodge's economy was just beginning to rebound. Back then, there were still boarded up stores a few blocks to the north. Property values all over town were generally low. Also, the Henderson property was so run down it did not even have a working fumace or heater. It was in bad enough shape that none of Mr. Henderson's dozen heirs wanted it and the probate estate had been unable to sell it. A measure of how low things were back then is that a couple of months earlier, when the probate estate conducted a well-advertised probate sale, nobody showed up. Not even to watch, let alone bid on the property. The estate had the property appraised at \$1800 (about \$17,300 in today's dollars. The Trustees were able to buy the property in June for \$1675, which is the equivalent of about \$16,500 in today's dollars.

Doubtless, the new Board of Trustees was looking ahead to the construction of additions to the Church, but the immediate plan was to use the Henderson house for one of the Sunday School classes. (The now combined classes were twice as large as the ones housed in the Church before the merger). Financing the purchase so soon after the merger took some financial creativity. The Community Church was just getting organized. It had not yet filed incorporation papers in June. It did not have legal title to any property. Legal title to this church building and the parsonage at 14<sup>th</sup> and Hauser were actually held by the Methodist District. Title to the Congregational Church and parsonage over on Word Avenue was held by the Congregational Conference, although the local congregation did have title to a rental property down the block on word. Both church properties had mortgages with their respective denominations. Sorting out transfers of titles and mortgages would (and did) take time. Also, the Community Church had Rev. Rushing and Dodds as co-pastors, each with his family in a parsonage. For the time being, the Methodist District and the Congregational Conference were leasing the respective properties to the new Community Church pending the sorting of titles and mortgages. So, the Trustees took out a short term loan for \$1500 from First Security Bank. The loan and some funds on hand allowed them to buy the Henderson property in June and pay for a gas wall-furnace to heat it for when used as a Sunday School classroom. The loan was paid-off about six months later when the Congregationalists's rental property was sold for \$1700 to the St. Agnes Catholic church which owned the rest of the block. They owned it all when they bought the old Congregational Church and parsonage property the following year. This was after Rev. Rushing was called to a ministry at a Methodist Church in Colorado and only one parsonage was needed. The \$15,000 price in that sale enabled the Community Church to pay off all the old mortgages and provided a substantial addition to their "building fund" for adding classrooms and office space to the original building here.

As things turned out, it was four years later, in 1968, before the Community Church was ready to build its new addition with enough class rooms for Sunday School, an entry ramp and doorway on the south and with the sanctuary reoriented to face the big stained glass window that is now regarded as a focal point of our Sanctuary. In the spring of 1968, after we had bought the other property – the one adjoining the Church on the north --- the Building Committee hired Drake Gustafson Architects to design the additions that would utilize the Henderson property. A congregational meeting was called to approve the plans; it was scheduled for the end of October. A couple of weeks before that meeting, Pastor Zimmerman and a crew of volunteers dismantled the old Henderson buildings, clearing the way for new construction... The lumber was saved for improvements to the parsonage property at 14<sup>th</sup> and Hauser.

The architect's plans may have been a bit more than the congregation anticipated. Besides adding a new wing to the south and east sides of the original building, there was also a major facelift of the front façade. The photo below, from a November 1968 article in the Carbon County News, shows what was proposed for the front.



Although unanimously approved by the congregation at the October 1968 meeting, there were second thoughts about the ideas for a new "A-Frame" front façade. At first, they put off a final decision by designating that part of the design as something to defer for a future "Phase 2" of construction. By the time eventually Phase 2 started in 1978, nobody was still considering an updated front façade. Of course, the ramp entry and the "Christian Education Wing" were built as planned. Also in Phase 1, the Sanctuary, which had faced the back wall for the previous six decades, was re-oriented to face the "Maria Cooper Window." Today, that window is still regarded as a major feature of our sanctuary – so much so that a photo of it was included in the Church Profile prepared for the pastoral search. So, what you see here is a road not taken.
